Student ambassadors assisted this month with tours, Crownie Night at the football game, Run for the Schools, Homecoming Pep Rally, as well as the Foundation Donor Dinner. Student Ambassador group picture was sent to the Press Citizen, Catholic Messenger and posted on Facebook. November 10th is their next meeting.

Finance / Operations Board Meeting Report Alan Opheim – Director of Finance and Operations October 27, 2015

Business Office -

- Busing The second of what is now projected to be three meetings was held October 19. This was a
 brainstorming session to discuss various aspects of the bus issues that Regina will face in coming years, and
 possible options to those hard choices. Those ideas will be summarized and along with additional information
 we have requested from Durham will be discussed at the next meeting, with a report to the Finance Committee
 to follow.
- A personal goal / challenge to complete the 1st Quarter financial package by mid-October and conduct the Board and Committee financial review was done October 21. The on-going goal / challenge is to monthly provide the previous month's results during the 3rd week of the month. The September 2015 summary is included in the Board packet.
- Both Sandy and I continue to spend the majority of the time with day-to-day needs, along with quarterly reports that consume Sandy's time, and for me progressing into the FY 17 budget process.

Special Events / Fundraising

- Fall Fun Festival currently exceeds a Net Profit in excess of \$30,000 with a budget of \$25,000. By the end of October all bill for the event should be paid, and a final projection ready.
- With late sales, it now appears the Benchwarmer fund raisers may exceed \$12,000.

Buildings & Grounds

- Nationwide Jim continues working with Nationwide in their conversion.
- Holes and indentions in the ground surfaced in the last month. After a review by Valu-Con, Tomlinson-Cannon, and other individuals, it is determined that we do not have serious issues, but we will be mud-jacking the loop in 2 places, and replacing the "throat" to the drains. Exact cost is still being determined. There should be minimal inconvenience during the repair.
- Don continues to make the transition of our cooling system to our heating system and dealing with the annual repairs and maintenance that comes with that process.

Building and Grounds

No Committee meeting in October; Update Below

TO: Building & Grounds Members

FR: Alan Opheim DA: October 23, 2015

Since we did not meet this month, I write to share a few items with you.

- As is typical at this time of year, Don is experiencing various HVAC issues in the transition from summer to fall/winter. Our most serious appears to be a compressor is out on one of the rooftop units. Estimate to fix is not yet available. He has had numerous smaller issues in about 5-8 classrooms and in his usual thrifty ability has found some great bargains of new equipment. He is confident that by the first long-term freeze we will be ready.
- You may have noticed some caution tape along a couple of spots on the loop. Two holes were discovered, one 3-4 feet deep. Upon inspections by Jim, Valu-Con, Tomlinson-Cannon, and others, it has been determined that mud-jacking the area is the most economical at this time. That work will be completed, we believe, in the next 1-3 weeks.
- The sidewalk along 2218 Rochester had 3 panels of concrete that exceeded the City's safe scale. Valu-Con has fixed those and donated labor Thanks Mike!
- Various spots in the front loop, back drive, and front parking have been patched to bring potholes to a reasonable depth and size.
- Jim is working on a long list of proactive repairs and maintenance around the school. So far, many are plumbing related or tied to playground equipment needs.
- You will notice that the baseball infield has been stripped. This ties to the project discussed earlier in the summer and last fall.
- Insurance claims for lightening and wind damage a year ago remains open a crane is expected when the winds die down, and schedules permit to get the light standards straightened. That is the last piece that insurance is expected to cover and should be between \$1,800 and \$2,500.
- One of the items noted at the start of the school year is the appearance and shape of our carpets. We will begin soon the process of obtaining quotes for rooms. We ended up putting new carpet in two classrooms and an area in both offices. Bachmeier did the work, and we were very pleased with their efforts. That said, our job will likely be larger in 2016, so we want to be sure we are getting the best product at the best price.
- We are in the process of getting a painting quote for the west side of the HS gym (exterior) and may get a quote for siding the same area. As you know the paint only held 4 years before pealing, so we want to be sure we have something with a longer life this go around.

If you have any questions or comments, be sure to let Jason or me know. Due to calendaring, I'm not sure of the next meeting date at this writing. I have a conflict on our scheduled November 9 date and November 2 is hopefully a playoff game. We will advise.

Review committee goals for 2015-2016

a. ALICE training, update from Glen and Celeste to confirm next training dates.

We have confirmed this will take place January 18th from 8:30 to 10:30 with the ICPD.

b. Health Information readily available to Coaches. Do we need to purchase IPads for coaching staff?

This fall, Carolyn Sueppel printed the emergency card for each player and placed it in a book. This book was given to each coach for the fall activities. Carolyn is still working on an App called "R school". This app will allow coaches to access their student athlete's medical history and current medical problems via phone or tablet. More to come on that!

c. Regina obtaining a School Nurse. Celeste and Glenn are putting a list together of medical problems that we address daily/weekly at Regina.

Bill reported on the different challenges they see day to day in the elementary. They have numerous scrapes on the playground, three broken bones this year, many kids with inhalers for Asthma, 5-6 students with various medications, and 15 students with Epi Pens. They also deal with the other medical problems like lice, chicken pox, food allergies, and bee stings. Tim noted HS students equal about 23 kids with Asthma, 5 with diabetes, a few with ADHD medications. Now that we know what we are dealing with for medical problems, Rick is going to discuss with Jan Miller requirements for schools and any paperwork required by the State. What in-services should be taught at Regina and who can do that? Once we discuss with Jan, we will look at engaging Mercy Hospital to provide funding or a nurse to assist Regina students.

d. Hosting a guest speaker at Regina to discuss safety or health topics targeting our students.
 We have secured a guest speaker, Craig Badura from Omaha. His topic is on Digital Citizenship. He will speak to the students, administration, and parents on March 28th.
 Need board approval and approval from Finance for funding \$3000.00 (all inclusive).
 I will work with PTO to see if they would like to team up for offsetting the cost and helping to advertise.

3. New Business

a. Thoughts or comments about the West High prank call. Are we doing everything possible to keep our kids safe here?

Tim reviewed our "crisis plan" and I have added that to the board for discussion. Currently the plan calls for President to address parents and Media, we may need to review this policy and change to meet our new organizational structure.

REGINA INTER-PARISH BOARD OF DIRECTORS/BOARD OF EDUCATION MEMBER POLICY

Reference Article 4, Section 3 from By-Laws of the Regina Inter-Parish Catholic Education Center:

Number, Tenure, and Qualifications of the Board of Directors/Board of Education. The number of voting Directors of the Corporation shall be seventeen, and they shall be: the Bishop of the Roman Catholic Diocese of Davenport; the Pastors of the four Roman Catholic parishes of Iowa City: St. Mary's, St. Patrick's, St. Thomas More, and St. Wenceslaus; and twelve lay Directors: three from each of the four parishes. Lay Directors shall be selected according to the procedures established in their respective parishes and shall be appointed by the Bishop to serve a three-year term. The Bishop may remove a Lay Director with or without cause at any time by written notice of such removal mailed to the Provost of the Board with a copy thereof mailed to the Director who is removed. A lay Director may also be removed from the Board if the Director is absent from three consecutive meetings of the Board or any four meetings of the Board within a fiscal year. A vacancy among the lay Directors because of death, resignation, removal, disqualification, or otherwise shall be filled by a lay person from the parish where the vacancy has occurred using the procedures established by the parish for filling vacancies. A vacancy among the Pastor Directors shall be filled by the priest appointed by the Bishop as Pastor or Administrator of the parish where the vacancy has occurred.

(In alignment with diocesan staff handbook, the following categories of employees may not serve on the board: teachers under school year contracts, regular full time employees, regular part time employees and part time employees.)

ATTENDANCE/TERMINATION (Ref. Article IV. Section 5, By Laws)

All members of the Board of Directors/Board of Education are expected to attend all Board meetings. This includes all regularly scheduled and emergency board meetings.

If any lay member misses three consecutive board meetings or any four meetings in a fiscal year, the president shall direct the secretary to send a letter to the board member reminding them of this policy. In July of each year this policy shall be inserted into the Board Packet so that all new and old members are informed of the attendance requirements. The president of each parish council shall also be notified of this policy.

- 2. Attending: Rick Larew, Father Steve Witt, Bill Battisone, Scott Nibaur, Shelly Conlon, Noel Verducci, Ann Larew
- 3. Bill Battisone, elementary school vice principal, presented copy of <u>Practice Makes Catholic</u> (book being used as a faculty K-12 study guide) as well as Diocese of Davenport Safe Environment Local Designees Manual He also presented happenings in the elementary school as far as masses, prayer services, service projects. Shelly Conlon presented 7-12 reports about religious events taking place

Feedback from staff (Catholic and non-Catholic) about <u>Practice Makes Catholic</u> study has been very positive. It has generated good discussion

- 4. Discussion of K-12 further education for faculty as far as religious training for faculty. Both online and personal retreats/training are possible. There was discussion as far as desire to make these further studies both accessible and financially feasible for faculty members who would like to pursue them. Bill Battisone will explore costs for continuing education with as many specific details as possible so that recommendations can be made as to reimbursement for faculty for their participation. He will report back to this committee and then funding sources will be explored (current school funds, future funds in new budgets, donor funds, etc.) Faculty will then be encouraged to pursue further studies.
- 5. Discussion of further uses of Catholic symbols throughout the high school and elementary. Possible use of statues that are available in all 4 parishes that are not in use will be investigated Noel Verducci volunteered to visit the parishes and make an inventory of available statues and religious symbols. Committee members will investigate further uses of symbols, quotes, religious paintings thought the school
- 6. Scott Nibuar reached out to Ms Marcotte, Regina choir director, and Joe Mattingly, music director at the Newman Center, to discuss collaboration they will work together to prepare joint concert possibly at Christmas and for sure in the spring. Scott will facilitate further discussion and ongoing joint ventures between music departments at Regina and the Newman Center.
- 7. CARA report discussion of the report and the 3 missions of the group that created the report. They are gathering information and this report is a summary of their findings. Baptism numbers are stable (from mid 1900s) but almost all other statistics have changed. Conclusions: current Catholic parents are just as likely as older Catholics to believe core Catholic values. Current generation of young (school age though 20s) Catholics have grown up in an age of unprecedented technology how does a 2000 pus year old institution relate? Current generation of Catholics are very diverse ethnically, culturally, racially, even more diverse than the population in general. There will be ongoing reading and discussion of this report and how the information can be used to help us at Regina and in relationship to current Catholicism.

 8. New business Relationship of home school students and Regina discussed. In years past,
- diocesan "rules" prevented home schooled students from participating in Regina activities, including academics, sports, music, etc. Home schooled students do participate in public school activities. There was discussion of this and committee members wondered about current diocesan rules and attitudes about this issue. The committee will ask the Regina Board of Education about this issue and whether home school student participation is a subject that could be clarified at the diocesan level or with the superintendent of diocesan schools. This committee will take no further action on this issue unless directed by the Regina Board of Education to pursue it.
