TRANSPORTATION WAIVER AND AUTHORIZATION FORM
(To ride with parent drivers, Regina employees, and fellow students)

I hereby give permission for my child/charge (“child”) to be transported in a motor vehicle driven by 1) fellow parents/guardians of Regina students, 2) Regina employees, 3) Regina volunteers, and 4) fellow Regina students for travel to and from practices, camps, meets, games, rehearsals, performances, and other off-campus events (“Events”) on the date(s) indicated above. I understand that it is my responsibility, and not Regina Catholic Education Center’s responsibility, to arrange such transportation for my child. I understand that my child is expected to follow all applicable laws regarding riding in a motor vehicle and is expected to follow the directions provided by the above-listed drivers, as applicable.

I have read, understand, and discussed with my child that:

- My child will be traveling in a motor vehicle and must wear a seatbelt while traveling;
- My child is expected to respect himself/herself, the other individuals in the vehicle with my child, and the vehicle itself;
- My child is to remain in his or her seat and not be disruptive to the driver of the vehicle.

I recognize that any activity involving motor vehicle transportation, including the transportation anticipated by this Transportation Waiver and Authorization Form, carries a risk of personal injury and/or permanent loss. I hereby attest and verify that I have been advised of the potential risks, that I have full knowledge of the risks involved herein, and that I assume any expenses that may be incurred in the event of an accident, illness, or other incapacity, regardless of whether I have authorized such expenses.

As a condition for the transportation received hereunder, I, for myself, and on behalf of my child, hereby release and forever discharge Regina Catholic Education Center and its agents, officers, employees, and volunteers from any and all claims that I might have myself or that I could bring on by child’s behalf with regard to any and all losses, claims, demands, suits, actions, judgments, awards, damages, liabilities, and costs whatsoever, including those based upon negligence, in any manner arising out of the transportation anticipated under this Transportation Waiver and Authorization Form. I further agree to defend, indemnify, and hold harmless Regina Catholic Education Center and its agents, officers, employees, and volunteers against any and all losses, claims, demands, suits, actions, judgments, awards, damages, liabilities, costs, and reasonable attorneys’ fees arising out of any third-party suit, action, or proceeding resulting from the transportation anticipated under this Transportation Waiver and Authorization Form.

It is my express intent that this Transportation Waiver and Authorization Form shall bind me, my child, my spouse, and the members of my child’s family. I have read this entire Transportation Waiver and Authorization Form, fully understand it, and agree to be bound by its terms.
