year in review

NEW TECHNOLOGY

For the 2020-2021 school vear. Regina invested in Chromebooks for students in grades 1-5. All students in grades 1-12 will have their own Chromebook to use at home and at school. Kindergarten students have access to iPads. All K-12 teachers have a new device called "Swivl" to help with hybrid learning. This device allows students at home to track a teacher's movements around the classroom. They can hear and talk to teachers as if they were sitting close to them.

Through the CARES Act,
Regina was able to purchase
higher-performing teacher
laptops which provide a
better streaming experience
for online learning. Additional
WiFi hotspots are available
for students if they do not
have internet access at home.
To help facilitate increased
internet traffic and the number of
connected devices in the school,
wireless access points, new
core servers and switches were
added throughout the building.

egina Catholic Education Center has adapted, transformed, reshaped, reorganized and embraced change as a school community in response to the global pandemic that has impacted our world since early 2020. We have adjusted to new conditions.

We are proud of our faculty and staff's response to the mandated closing of lowa schools in the spring, and our ability to transition quickly to online continuous learning to finish the school year for grades Pre-K to 12th. Our mission has held strong: Regina is committed to preparing tomorrow's leaders through a comprehensive educational experience focused on excellence and anchored in the teachings of the Roman Catholic Church. That mission hasn't changed during these circumstances.

Even while our buildings were closed, work behind the scenes continued. Our teachers prepared online learning opportunities and resources for their students and worked to keep our young people as engaged as possible. In other words, while our buildings may have





been temporarily closed, school was still very much in session. We were able to provide our seniors with an in-person graduation ceremony, something many seniors across the country were not able to have. It looked a little different than years past, held outside on the football field and wearing masks, but the students in our Class of 2020 were able to walk across the stage, receive their diplomas and have that milestone memory that they deserved.

Regina Jr./Sr. High principal, Glenn Plummer, was chosen as the recipient of the Spark Award for the 2020 Innovation in Education Awards presented by the Iowa City Area Development Group and the Iowa City Area Business Partnership. These awards honor educators, students, and classroom programs that model the future of K-12 education. The Spark Award is given to an administrator who goes above and beyond what is expected in order to create a learning environment where all students have a chance to succeed and all instructors feel the freedom to innovate. Endowment gifts support students, faculty, and programs and ensure the long-term financial health and support of the Regina Catholic Education Center for years to come in addition to providing annual support.



capital campaign update

In Gratitude

Through their generous investments, they ensure the very best opportunities for students at the Regina Catholic **Education Center.**

egina recently completed construction of a new junior/senior high education wing. The one-story addition features 11,723 square feet of new construction including four classrooms, a science lab and flex space for Regina junior and senior high students. Other features include a 2,750 SF lobby/ atrium, concession stand, Spirit Store, athletic trainer's room, restrooms, trophy cases and an entrance for extra-curricular activities.

> Students entered the wing for the first time when fall classes resumed on August 24. "It was awesome seeing students in the halls," said Glenn Plummer, junior/ senior high principal. "There were many comments about how great the wing looks."



The new lobby area has been helpful as the school works to promote social distancing in the midst of the COVID-19 pandemic. "The new lobby gives us another large space to use for lunch and classes," Plummer said.

Construction of the addition began on September 23, 2019, and finished a month early on July 17, 2020.

The project is one of the final components of the *Pride* in Our Past, Building Our Future Capital Campaign that









launched in 2016 and initially raised \$4.83 million in Phase 1, allowing Regina to address multiple needs throughout the campus.

The "exciting next step" for Regina will be converting the newly-freed-up space in the original structure into an expanded early childhood education center, Regina Elementary principal, Celeste Vincent, said. Currently, pre-kindergarten classrooms are in two separate locations in the school; having all classrooms in the same hallway will allow for more cohesive theming and programming.

FEATURED ARTIST: Rev. EDWARD CATICH

ou may recognize the art images throughout this publication if you are familiar with the unique slate and stained-glass artwork at Regina. You may not, however, know about their origins or their famous creator.

Rev. Edward M. Catich was the founder of the St. Ambrose College (now University) Art Department in 1939. He was known as one of the world's finest calligraphers; an international authority on stone incising, typography and stained glass fabrication; and the foremost authority on the Roman alphabet, its origin, nature and history. Although Catich was described as theologically conservative, he enjoyed shaking things up at the pulpit and through his art by being modern. "A basic principle of religious art is that we must express religious truths in

contemporary terms," he contended. His calligraphy and stone cutting work won Catich an international reputation, and he created many slate inscriptions using his brush and chisel technique. He created two typefaces, Petrarch and Catfish. Many of his books were published under his own press, The Catfish Press, which operated out of his studio at St. Ambrose.

In 1959, he created Stations of the Cross for Regina High School that portray Christ and his contemporaries as modern-day figures "because," he explained, "[the stations] are to be used by people living today, not in the Medieval, Renaissance or early Christian era... I wish people to see themselves in these Stations and so in the Stations there are laborers, appeasers, intellectuals, and even little children — and all dressed in present day clothing.... We have Pontius Pilate on a swivel chair, glasses on his forehead and reading his legal documents. The soldier guarding Christ holds a left-handed Browning five-shot automatic." He also created interior and exterior images on two-inch-thick slate and stained-glass windows in Regina's chapel.

Other institutions which hold his work include Harvard University, Los Angeles County Museum of Art, Encyclopædia Britannica's corporate headquarters, and University of Pittsburgh's Cathedral of Learning and Benedum Hall.

The Catholic Messenger, which had published so many of his expositions on religious art, commented that "to the ordinary, he seemed a recluse of sorts," yet "the mark of talent is everywhere." Catich did not seek fame; it found him. He was "such an extremely modest man" who "could be quite ignored in his own town," said Kenneth Donahue of the Los

Angeles County Museum. "But in Los Angeles, he's a famous man." In spite of his renown, Catich chose to remain at St. Ambrose. He was found dead in his studio on Good Friday, April 14, 1979, at age 73.

The next time you are at Regina, take some time to appreciate Rev. Catich's artwork, the importance of his theological message, and Regina's good fortune to have his famous talent on display.
